UNOS Facing Pressure to Change

In March of 2023 the Health Resources and Services Administration (HRSA) called on Congress to help make changes in organ retrieval and distribution in this country. This was no surprise move by the Biden Administration. The call for change follows years of scrutiny, uncovering many examples of available organs being wasted and too many distribution failures resulting in unnecessary deaths. These and other long-standing issues have resulted in various calls for much needed change soon. Currently there is no timeline for change, as many issues are quite complex and thorny. United Network for Organ Sharing (UNOS) officials, for their part have listened attentively and made efforts at reform. However, in past speeches they point to their successes, that the system is working better every year. In 2021, for instance the US performed 41,354 organ transplants, the highest number for any one year since we started keeping records in 1987. There were also ever-higher numbers of kidney, liver and heart transplants in 2021 and 2022. Critics applaud those UNOS efforts and accomplishments but are steadfast in pointing out UNOS has not been serious enough about effecting serious consequential change. Many viable organs made available for transplant are being discarded because the distribution

system is inadequate. Some organs extracted for transplant are viable but aren't being transplanted. Critics argue more people are dying that could be saved if the system operated more efficiently. Look for this debate to continue. But make no mistake, the world of organ transplantation is changing in America. Expect to see changes soon.

California AB 2504

We should be aware of California Assembly Bill 2504 (AB2504, introduced by Ash Kalra, San Jose). It is called the 'Living Organ Donor Reimbursement Act." There are many financial reasons why people are reluctant to volunteer to be living donors. Insurance companies and organ transplant hospitals have done lots to help ease the financial strains live organ donation imposes on living donors, but many significant expenses still have to be dealt with. These costs are sizable stumbling blocks to volunteering to be a live organ donor. That's where AB 2504 comes in. The bill authorizes living organ donors to apply to the department of Health Care Services for reimbursement of qualified donation expenses that were not, or will not, otherwise be reimbursed, including travel and lodging expenses, lost wages, childcare costs, copayments and deductibles for prescription and over-the-counter medications needed as a result of the donation. The bill would limit the total reimbursement costs awarded to each living organ donor to \$10.000 per organ donation. Despite the fact organ transplants are increasing every year during at least the past decade and recognizing 2022 saw UNOS organ transplants exceed the one million organ mark, there is little disagreement that too many people are dying in this country because they are not getting that organ transplant they so desperately need. This bill is the first such law being considered in this country and since living organ donation is one area where we could see improving numbers fairly quickly perhaps our group can discuss this at our next meeting and in the future to see if we would like to show our support. The Bill was introduced in 2022 by Assemblyman Ash Kalra of San Jose. It appears to be tabled in Committee, awaiting a hearing.
