## *Boosting the Number of Available Hearts*

## Does This Chart Surprise You?


The chart below might surprise you. It surprises me no end. It shows that despite all the success we've seen with the new Hepatitis C Virus vaccines, which are a virtual cure, a 90%+ cure rate), the number of people being treated has been steadily declining from 2015 to 2020. At the moment the numbers of people taking the vaccines in 2022 and 2023 are soft and not yet reliable, but it appears this downward trend is continuing. I wonder why. One might think this simply shows the numbers are decreasing because fewer people are HCV positive. That is simply not the case. The CDC believes there are still nearly four million people in the US infected by HCV. That four million rate has been fairly constant for a decade or more. The number of liver transplants in 2021 exceeded 9,000 for the first time ever and 2022 there were just over 9,100. Liver transplants in 2023 are on track to exceed 2022 numbers. So we are doing more and transplants each year. Some might argue the cost for the vaccine is prohibitively high and that scares people away, but prices are going down and in some cases, few though they may be, you can get this vaccine in some cases for about \$5.00 a dose.

It's a mystery I thought worth pointing out. This virus is a killer and, as a group we know that better than most people. Perhaps these numbers are reminding us that HCV, once called a Silent Killer, still is because the symptoms come on slowly most of the time, and are often ignored initially, but they only get worse over time. When these vaccines appeared some ten years ago I imagined HCV as the number one reason for a liver transplant would be supplanted by the former number one cause, alcohol abuse. But that is not the case. HCV still wears that crown of thorns, with fatty liver coming up fast.

The chart below shows the estimated annual numbers of people treated for hepatitis C in the U.S. from 2014 to 2020. The number is highest in 2015 (the end of the first year of the study), and lowest in 2020. Note the overall decline in participants.

### **Living Donor Protection Act of 2023**

Our last newsletter addressed Assembly Bill 2504. It is sitting in California's Assembly Chamber awaiting consideration. But the federal government and some States are starting to enact and pass bills extending tax credits to employers and individuals and helping would-be living donors get the paid time off they need to give the gift of life without hesitation. I say that is a good start. They should not let the additional medical costs for living donors be a big problem down line. There is an increasing awareness in this country that living donors can ease a lot of pressure in our world. We need to take steps to see that all obstacles are off the table. One such piece of legislation I referred to above is the '**Living Donor Protection Act of 2023**'. The act aims to remove barriers to living donation and provide greater protections for living organ donors. There is no doubt a shortage of deceased organs for transplant in this country. Congress must do everything possible to promote living donation. I think we should recognize, even applaud our Congressional Champions for reintroducing the **Living Donor Protection Act of 2023** and for recognizing the critical need to support living organ donors.

"We must do more to remove the barriers that keep Americans from life-saving organ donations," said Senator Kirsten Gillibrand (D-NY). "The bipartisan Living Donor Protection Act would help ensure that individuals who are willing to save someone's life through organ donation can do so without worrying that they'll face harsh repercussions, like insurance discrimination or job loss. Enshrining these protections for donors will help save lives, and I will keep working with my colleagues across the aisle to finally pass this commonsense legislation."

#### **About the Living Donor Protection Act**

It will protect living organ donors and promote organ donation in three easy, low-cost ways:

- Prohibits companies and individuals from denying or limiting coverage and from charging higher premiums for living organ donors;
- Amends the *Family and Medical Leave Act of 1993* to specifically include living organ donation as a serious health condition for private and civil service employees, and;
- Directs the U.S. Department of Health and Human Services (HHS) to update their materials on live organ donation to reflect these new protections and encourage more individuals to consider donating an organ.


